As a participant in our referral program, you can earn one free month of subscription at the end of your current subscription term for all your existing UVeye systems—and the referred dealership will also receive one free month—for each referral that enters into a contract with UVeye, subject to the program terms below.

To Submit a Referral

- 2. **We'll Take It From There:** One of our Regional Sales Managers will review the referral and make the warm handoff to the prospect.

Referral Program Terms & FAQs

Can this be an existing working lead?

No, the referral program is only applicable to new prospects who are not currently working with UVeye. A UVeye Regional Sales Manager will confirm if the referral is eligible.

How is the referral handed off to the UVeye Sales team?

An email or text with the referral details will be shared with both the Regional Sales Manager and the participant. The Regional Sales Manager will then contact the prospect directly to make the warm handoff.

How long does this referral program run?

The referral program is active through **December 31, 2025**. UVeye reserves the right to modify, suspend, or terminate the program at any time with or without notice.

How long is your referral valid?

After submission, the referred dealership has **90 days** to enter into a contract with UVeye for you to earn the referral reward.

What is the reward per signed contract?

Eligible referrals that enter into a contract within 90 days of submission will earn your dealership one free month of subscription for all your existing UVeye systems.

Are there limitations on earning referral credits?

No limits exist on the number of dealerships you can refer to. However:

- Only one reward is earned per successfully referred dealership.
- You cannot refer dealerships within your own dealer group.



When do you receive the reward?

The free month of subscription will be applied at the end of your existing subscription term once the referred dealership signs a contract with UVeye.

Does the referral program include adding stores within your own dealer group?
